Non-refundable registration fees must be paid prior to uploading the final IEEE formatted, publication-ready version of the paper. There must be one FULL AUTHOR registration for each regular nine (9) page paper. For authors with multiple accepted papers, one full registration is valid for up to: a) One (1) regular paper + one (1) short (five 5 page) paper +one(1) poster; or b) one (1) regular paper + two (2) short papers; or c) one (1) short paper and two (2) posters.) Accepted papers will be published in the IEEE IWQoS 2010 Conference Proceedings. Accepted and presented papers will be published in the IEEE IWQoS 2010 Conference Proceedings and in IEEE Xplore®. Co-authors of papers that are already represented by the FULL paid registration of one author are not required by register in the FULL AUTHOR registration categories (RG01, RG02 and RG03.)
